Sir,

At the outset we would like to introduce our organization Central Warehousing Corporation which was established in 1957 under the Agriculture Produce (Development & Warehousing) Act 1956. This Act was repealed and replaced by Warehousing Corporations Act 1962. The Corporation has been working under the administrative control of Ministry of Consumer Affairs, Food & Public Distribution, Govt. of India.

To begin with, the Corporation started its business with 7 Warehouses with a meagre capacity of 7000 metric tonne. As of now there are 464 Warehouses, 57 Custom bonded Warehouses, 31 Container Freight Stations/Inland Clearance Depots and 03 Air Cargo Complexes and 02 ICPs across the country. Thus we have pan India presence. These field formations are being controlled by 18 Regional Offices.

The Corporation conduct various training programmes especially on Warehouse Management with our expertise in this field. The training programmes are tailor-made to suit the needs of all rungs of employees

It is informed that CWC has taken over the Management of Training Activities at IGMRI Hapur alongwith their hostel. All the programmes will be on residential basis and the training/hostel charges are nominal. The course fee have also been fixed at very nominal rate to meet the cost of training w.e.f 1.4 2016. The details are given below:-

05 days programme | Rs.11,100/- + service tax |
