
The Quotation shall be sent by Speed post or delivered by hand well in time so that the same reached **Central Warehousing Corporation, Inland Container Depot, Patparganj, Near Ghazipur, Delhi- 110096** which shall be opened in the presence of parties/authorized representative who wish to be present at their own cost. The Quotations received after due date and time shall summarily be rejected. The authorized representatives have to produce the necessary authorization for this purpose. **Schedule of quotation given below:**

Date & time of receipt of quotation: 04.09.19 up to 03:00 P.M.
Date and time of opening of quotation: 04.09.19 at 03:30 P.M.

1. If the day fixed for opening of quotations is subsequently declared as holiday, the quotations will be opened on the next working day. Conditional quotation liable to be rejected.

Annexure-I

Terms and Conditions of contract:

1. The rate quoted is Rs. -----/kg inclusive of all taxes except GST.
2. The rate quoted is inclusive of destruction cost, transportation cost, loading/unloading of cargo.
3. Party shall provide destruction/incineration certificate alongwith of photo/video of each consignment.
4. All the NOC/Certificate as required from CPCB/NGT/Police Station/Gram Panchayat/State Government/Central Government/Other Agencies as required will be taken by the party.
5. CWC shall provide only NOC from the Customs Authorities for the destruction of longstanding cargo.
6. Payment shall be made by CWC in favour of party within 45 days through cheque/DD/NEFT/RTGS after submission of GST Invoice alongwith all the details as mentioned at point no. 3.
7. The contract period shall be of one year and same may be extended for another three months at same rate terms and conditions by Manager ICD-PPG.
8. Document to be attached during submission of NIQ:-
 - a. Party should have minimum five year work experience in the field of destruction with documentary evidence.
 - b. The turnover of the company should be minimum Rs. 5 Cr. in a financial year during last preceding three financial years and should submit copy of audited balance sheet/P&L Account/CA Certificate as a proof of turnover for FY-18-19,17-18,16-17. In case accounts of party for FY 2018-19 are not available, party may submit the same for FY 2017-18, 16-17 & 15-16.
 - c. i. Copy of PAN Card of firm/company.
ii. Copy of GST Registration Certificate.
9. If party fails to do destruction of minimum 100 MT. Cargo within 30 days of lifting the cargo from the site i.e., ICD-PPG then penalty @ Rs. 5/Kg. will be imposed for the leftover cargo.
10. CWC has right to appoint/award the work to any other agency if the performance is not satisfactory during the contract period and the risk and cost for destruction of such lots will be borne by the party.
11. The corporation reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
