1.	DESCRIPTION	IMIDACLOPRID 30.5% SC (PREMISE)
2.	FORMULATION	Suspension Concentrate
3.	SPECIFICATION	The products shall be of recent manufacture and conforming to IS 16131. The supplier has to furnish manufacturers test certificate and undertaking in this regard that their product conforms to the required IS specification.
4.	GUARANTEE	The product shall be guaranteed against any deterioration in quality for a period of one year from the date of manufacture.
5.	PACKING	Packing shall be as per IS: 8190, Part-II-1988 with up to date amendments. The material shall be packed in Five (5) liters tins, strong enough to withstand rough handling in transit.
6.	MARKING	The container shall bear legibly and indelibly the information as required under IS: 2567-1978 and the Insecticides Act and Rules.
7.	Quantity	As per Annexure-II.
8.	RATE	Rate should be quoted inclusive of all taxes, octroi charges, duties levied or May be levied, packing handling, Insurance charges etc. FOR Destination in Odisha. The rates quoted shall be valid for a period of six month from date of award of Supply order.
9.	DELIVERY	The required quantity shall be dispatched through quick mode of transport at respective Central warehouse in Odisha state after receiving the dispatch advice from CWC RO Bhubaneswar.
10.	Consignee	Would be intimated later.
11.	INSPECTION	The Corporation may at its discretion draw random samples in respect of supplies made in the presence of supplier or his authorized representative who wish to be present. The supplier shall have to furnish an undertaking that in case the stores not found conforming to required specifications at any stage the same will be replaced with good one at his cost. Lab test charges if any will be borne by the supplier. The store received in damaged condition at the destination will have to be replaced by the supplier at his risk & cost.
12.	PAYMENT	The payment will be made on receipt of goods in good condition and submission of bill in duplicate.
