ANNEXURE-B

Terms & condition agreed upon for repair and maintenance service contract of weighbridge at CW, Chomu, Baran, Deoli, Kotputli, Jhujhunu, Udaipur, Kota-III, Sriganganagar-II, Bikaner-II, Sitapura-II and Hanumangarh-II- reg

1. If desires, the Contractor may visit the site for assessment of the nature/volume of work at their own cost prior to quoting the rate of AMC work,
2. The Annual Repairs & Maintenance Contract shall be applicable for a period of one year in the first instance since the date of joining after award and same can be extension for next year on the basis of performance of Party & at the discretion of CWC on the same rates, terms & conditions.
3. The contractor shall depute its skilled trained and Experienced Technical Staff / Service Engineer / Representative once in three months at least and also to attend any emergency call as and when required for the rectification of the defects of the Weighbridge in question.
4. The standard test weights required for checking of the machine shall be arranged by Central Warehousing Corporation. The stamping of machine and the different weights of as stated will be carried out by the Contractor on its due date from the Govt. Weights and Measurement Deptt. In no case the stamping work will be delayed by the Contractor and losses occurred to the Organization due to non-stamping of Weighbridge Machine shall be borne by Contractor. Contractor shall attend upon the Inspector of Weights & Measurement Deptt. Whenever re-verification of the equipment under this contract is necessary.
5. The contractor has to do the overhauling and painting of the weighbridge during the Contract. The date / period may be fixed in consultation with the concerned Warehouse Manager to avoid hampering of Weighment work in the Warehouse.
6. Each quotation must be accompanied with Earnest Money of 2.5% per lorry weighbridge quoted rates in the form of a Demand Draft issued by SBI or a schedule bank in favour of the Regional Manager, CWC, Jaipur. Quotations not accompanied by earnest money shall be summarily rejected. The EMD shall be liable to forfeiture of the Quotationer who after submitting his offer resiles from his offer or fail to furnish SD by due date after acceptance of his offer. EMD shall be returned to all unsuccessful quotationers.
7. The successful quotationer shall execute an agreement on non-judicial stamp of Rs 100 value paper within a week period and shall furnish within a week of the acceptance of his offer a security deposit of five times of EMD.
8. No interest shall be payable on the amount of EMD and SD in any case. The firm registered with NSIC may be exempted from furnishing EMD & SD on production of attested photocopy of Registration. SD shall be refunded after completion of contract

period satisfactorily and as per terms & conditions subject to recovery of any loss/damages suffered on account of failure on the part of AMC contractor.

9. The quotationer should have an experience of two year in the field of installation/repairing and maintenance work of ELWB and should produce a proof of having completed AMC work of two years successfully in any reputed organization.

10. The work of annual verification and stamping by the Weights & Measurement Deptt. will be got done by contractor at his expenses. Govt. stamping fees/stamping charges will be paid by CWC. However, compounding fees/penalty if any imposed by W&M Deptt., due to untimely stamping or any other irregularities on the part of AMC contract shall be borne by Contractor.
11. The rates quoted shall include free replacement of working parts. However, in case of major parts required (As per annexure "B"), if any during repairs, the costs of such spare parts shall be borne by CWC according to rate list enclosed with quotation and also no fluctuation will be borne by CWC, subject to prior approval of competent authority. Moreover, reimbursement of cost of parts shall be made on production of cash memo from reputed company and of good quality, responsible for supply of genuine/original parts with warranty when such parts are replaced.
12. The machine shall be attended by trained and experienced technical staff under expert technical supervisor to avoid any losses.
13. On the scheduled visit the machine will be thoroughly examined, repaired, serviced, rectified, adjusted and tested for accuracy.
14. Unskilled/casual labour needed for moving and lifting the parts of the machine and weights during the visit will be provided by the Corporation.
15. Whenever, machine comes under the control of the Weights & Measurement Authorities, the contractor would attend the inspection of Weights & Measurement Deptt. Whenever verification and stamping of machine is to be done by them. It will be his personal responsibility to attend the stamping work in presence of Weights and Measurement Deptt.
16. The Contract can be terminated by giving One month notice, in case service rendered by the Contractor are not found to be satisfactory and the work will be got done at the risk and cost of firm for remaining period of contract for that he will be solely responsible and SD will be forfeited. The decision of the RM, CWC, RO, Jaipur shall be final and binding on the Contractor.
17. The Contractor shall attend the LWB immediately but not later than 2 days from the date of receipt of complaint from the Warehouse Manager either through letter, e-mail telegram, phone, Fax etc. The weighment charges if any incurred by CWC within first two days from the date of receipt of communication to the Contractor Shall be borne by CWC but on failure to attend the LWB within first two days the weighment charges are recoverable from AMC Contractor after two days also recoverable. In case, defects are not rectified within 4 days of lodging of complaint the repair work would be got done

18. Repair & Maintenance Charges shall be paid quarterly on production of pre-receipted bills in duplicate along with service vouchers in original duly verified by the concerned Warehouse Manager. The voucher shall be supported by a certificate issued by the Warehouse Manager stating that the Contractor has attend the work as per terms & conditions of award and LWB is working satisfactorily.

19. Maintenance of battery is not the part of this Contract.
20. In the event of any dispute arising out of or in any way touching or concerning this AMC/work order whatsoever, the same shall be settled in the level of Regional Manager CWC, RO, Jaipur. If the agency is not satisfied with the decision of Regional Manager, Jaipur then the same shall be referred to the sole arbitration of a person appointed to the Arbitrator, by the Managing Director of the Central Warehousing Corporation.
21. The rates are exclusive of all taxes which are being levied or to be levied by the Central /State Govt./Local authority from time to time. The firm will be required to furnish Registration of the Central Excise Deptt. amount of service tax on the bill for the purpose of payment of Service Tax.
22. The contractor shall provide IT source code/password each ELWBs after proper repairs to concerned Warehouse Manager/Regional Office, Jaipur.
23. The conditional offer, if any will be summarily rejected.
24. The offer shall remain valid for a period of 90 days from the date of opening of quotations. The validity of offer beyond 90 days can be extended on mutually agreed terms & conditions.
25. The EMD may be adjusted as Security Deposit in case of successful quotationer.
26. EMD in case of unsuccessful quotationer shall be refunded after the date of award of work to successful quotationers.
27. The Corporation reserves the right to accept or reject any or all quotations without assigning any reason.
