1.	Description of stores.	Propoxure 20% EC - ISI Marked in 1(one) litres packing.
2.	Specification	ISI marked and as per IS 9665:1981 with up to date amendments, and should be of recent manufacture not more than two months old at the time of offering for pre-purchase inspection.
3.	Quantity to be supplied	100 litres of Propoxure 20%EC ISI Mark in one litre packing.
4.	Guarantee	The product shall be guaranteed against any deterioration in quality for a period of two years from the date of manufacture.
5.	Pre-purchase Inspection.
