

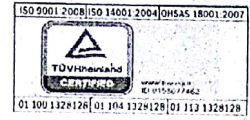

1.	Sample divider(Boerner type)	7	Brass eliminating possibility of rust, seed borrows shipping weight 15:422 Kg (34 lbs). The sample divider is reduce the size of a grain /seed sample into two equal halves, each exactly representative of the original sample. It has 38 opening/pockets. The grain falling down the sides of the cone is cut into 38 separate streams, rejoining into two streams which empties in to the pans. This divider is calibrated to provide accuracy of 1 % between pans on a 1 Kg. sample. The body and inner parts are made of brass. The legs & support are made up of chrome plated steel. The sample divider should have brass body with 2 brass sample pans. Easy to operate, smooth finish made without joints and no electric requirement.
