## TERMS AND CONDITIONS

1. Security Deposit will be deducted @10% of gross amount of bill of the contractor which will be refunded after successful completion of defect liability period of 6 months. In case any defects are found within defect liability period, the same shall be repaired by the Contractor immediately at his own cost. EMD deposited alongwith the quotation shall be adjusted against the security deposits to be deducted from the bills of the contractor.
2. Necessary taxes i.e. Income Tax ( except GST) will be deducted from the bill as per prevalent rate as on date.
3. GST or any other tax on input material or service used by contractor in respect of this contract shall be payable by the contractor and CRWC will not entertain any claim whatsoever in this respect.
4. The rates quoted by the contractor should be excluding GST or any other tax levied by the Central Government in lieu of GST and the same will be paid by the Company over and above the schedule of rates, subject to submission of tax invoice as per rules under GST Law.
5. Contractor will have to arrange all labour, T&P etc (at all levels) required for the execution/completion of the work as per site condition. Safety of working labour's lies on contractor only at all levels.
6. Items & Quantities given in the schedule are tentative to give an idea of work involved which may vary as per actual execution at site.
7. Work shall be executed strictly as per CPWD specification/Schedule. work is to be completed within one month from the date of issue of work order.
8. CRWC reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
9. The offer rate shall be valid for 60 days from the date of opening of quotation.
10. The time for execution of the work specified in the work order shall be deemed to be essence of the contract and the work must be completed within the specified period. If the contractor fails to complete the work within the specified period mentioned in the work order, the Competent Authority may at his discretion extend the date of completion and also consider levy of penalty as deemed fit based on the merit of the case.
11. If, the work is not started by the contractor within 1/8<sup>th</sup> of stipulated time.

Or

The contractor having been given a notice in writing to rectify, reconstruct or replace any defective work or fails to complete the work within the stipulated date or persistently neglects to carry out his obligations under the contract and does not remedy it or take effective steps within 7 days after the notice, the Engineering -in- Charge shall have power

to rescind the contract and the EMD, security deposit already deducted under the contract shall be liable to the forfeited.

12. No advance payment shall be made at any time and payment shall be made only after execution of items/ work.
13. In the event of any documents found forged/ fabricated/ tampered/ altered or manipulated, then the EMD of the Contractor would be forfeited and he would be debarred for participating in CRWC for 5 years.
14. Before quoting the rates, contractor in his own interest may visit the site under intimation to the concern Authority.
15. The work shall be performed only by valid electrical license holders of appropriate class as issued by State Government licensing Board.
16. The Electrician & helper engaged for the work must be well equipped with electrical tools & should possess the protective equipments and ensure safety.
17. The Contractor shall not sublet/ assign the contract work to any other contractor.
18. The contractor will have to abide by the labour laws and have to extend the statutory due benefit to the person deployed and the CRWC will not be held responsible for any compensation in case of any mis-happening during contract period.
19. The Contractor will sign each paper of Quotations in token of acceptance of their offer.
20. Contractors submitting bid on behalf of a firm/ Company must submit partnership deed or Certificate of Incorporation of the Company and Power of Attorney in the name of person signing the tender/ quotation.
